Thank you for your interest in the Manchester Police Department Citizens' Police Academy. The Police Department hosts its Citizens' Police Academy in the Spring and Fall of each calendar year. Please complete the entire application. There are some other aspects of the application process that must be adhered to and they are as follows:

- ✓ Applicants must be at least 18 years old at the time the selected Session starts.
- ✓ Applicant selection is based on the following order:
  1. Town of Manchester residents,
  2. Persons working within the Town of Manchester,
  3. Persons going to school within the Town of Manchester,
  4. Persons living outside the Town of Manchester.
- ✓ Applicants must submit their social security number for a criminal history check.
- ✓ Applicants possessing a driver's license are required to submit their respective driver's license number.

The Manchester Citizens' Police Academy is a sixteen-week program that is held in the Manchester Police Department's Community Room. During the sixteen weeks, the Citizens' Police Academy will meet every Wednesday from 6:00 PM to 9:00 PM.

Applicants can select to attend one of the following Sessions:

Spring 2010: 21<sup>st</sup> Session - Starts February 24, 2010 & Ends on June 9, 2010.

Fall 2010: 22<sup>nd</sup> Session – Starts September 1, 2010 & Ends December 15, 2010

Applications must be returned to the Manchester Police Department Headquarters Building no later than midnight on Saturday, February 20, 2010 for persons wishing to attend the 21<sup>st</sup> Session (Spring), and Saturday, August 28, 2010 for persons wishing to attend the 22<sup>nd</sup> Session (Fall).
